NOTICE OF HEARING AND MEETING OF THE STERLING COUNTY

The Sterling County Underground Water Conservation District (SCUWCD) will hold a PUBLIC HEARING at 1:00 PM on the 13th day of NOVEMBER, 2023 on the proposed revisions to SCUWCD Rules (Rules). The Board of Directors (Board) will consider revising the Rules at the Board meeting following the public hearing. The revisions considered encompass recent statute changes to Chapter 36 of the Texas Water Code which include definitions, how to petition for a rule change, hearing procedures and conduct, and general language clean up revisions.

SCUWCD uses these Rules as a guide in the exercise of the powers conferred by law and in the accomplishment of the purposes Chapter 36 and Chapter 8814 Texas Special District Local Laws Code. SCUWCD is committed to well owners, landowners, residents and the conservation, preservation, and protection of the groundwater resources in our area.
